December Report – Total Income \$5,694.63, Total Expense \$7,589.75 (Property taxes \$4,119.69, Donations \$1,176.50) which accounted for the bulk of expenses, Net Income for the month - -\$1,887.29

Income for 2014 is liable to be reduced as there will need to be a clay target order placed and the JOAD archery program is leaving. (We still have our own archery committee and events

planned)

The land acquisition fund and the Bond Scholarship fund did well in 2013 - dividends of \$963.13

Committee Reports:

Shoots Trap/Skeet doing very well. Trap/Skeet is opened every Sunday from 10 AM on and every Monday and Thursday evening starting at 6 P.M. Winter League continues and you may still join this shoot. Shooting will be on Sunday from 11-3 and Monday and Thursday

from 6-9.

NSSA Wednesday night events continue on the first Wednesday of each month. Cowboys reported 607 shooters for 2013 – Jan. Saturday shoot brought out 18 hardy souls. Thursday, Jan 16th Old Coot shoot – 9:30 AM – no lunch. The next regular cowboy shoot will be February 1^{st} – safety meeting at 9:30 AM and shooting begins at 10:00. Eye and ear protection are required for participants and spectators.

Equipment (bows/arrows etc.) is available for those who would like to try out this venue. It is shot indoors so you won't need your longjohns.

Board Meeting Minutes January 21, 2014

The Board was saddened to hear of the passing of long time member, Jim Irvine – Our condolences to Mona and his family.

Meeting called to order at 7:00 PM by chairman Barbara Blough. Tim Hall gave the invocation.

Jim Jones made a presentation about the various venues who have provided information to be distributed at the Gun Show. Some discussion about the need for a new banner – ours is over 10 years old. Revisions need to be made to a new banner reflecting all of our venues and this will be looked into and a cost estimate to be provided by the February Board meeting. Members are encouraged to stop by the club table, and sit and talk with people interested in our club activities. Applications for membership are routinely handed out.

- Bob Middlebrook is working on timers for our outside lights the gate light on our sign is back in operation.
- Another member is looking at replacing our old fluorescent lights on the 50 yard range with new LED lights.
- Jon Stotz has donated 49 bags of ice melt and used his big truck to spread ice melt on our drives and parking lot a big thank you!

• Our carpet was cleaned in the main building – thanks to Pete Kruer who donated the machines and materials and to the crew who worked to make our building look great! (Thanks to Gordon for heading this up)

• Dan Vincent reported that our various police agencies provide backers and other construction materials as a thank you for allowing them to use our range. A range will always be available to club members when police agencies are on club grounds doing their qualifica-

tions.

Business Items

*Correction to end of year treasurer's report. A \$3,000 amount that should have been reported for 2014 was mistakenly used in the 2013 end of year report. It has been corrected and the Board has approved this correction.

*Announcement to all shooters – Dan Hankinson reported that CCI, Winchester, and Remington have invested over \$20 million dollars in new lines to produce .22 ammunition. This means new jobs for people and the shortage of this ammunition will be eased soon. You can help – if you have 10 or so boxes of .22 ammo why not wait until the shortage eases up before purchasing more.. By this fall we should see shelves stocked again. MUCC (Michigan United Conservation Clubs) is working to collect 300,000 signatures as a counter measure to those who would try to control hunting in Michigan. (RSC will try to obtain at least a thoiusand signatures to help in this fight) Their first target – wolf hunting...soon to follow bear hunting and who knows where this will go. You, as a member, will be given the opportunity to collect several signatures on a petition form created by MUCC to help keep our hunting tradition. The Board is asking for several members to attend the District MUCC meetings to represent RSC on issues that we want brought before MUCC and to bring issues back from the meetings that would be helpful for our Club. As a member you can log into the MUCC website and read the monthly magazine. Contact Mike Roche for login information.

For an additional \$5 you can get the magazine delivered to your home.

Gordon is working with our representatives and MUCC spoke person Amy Trotter about our property tax issue.

Officer's Reports

<u>President</u> – George – There are three shows in town where MUCC will have a booth – the RV Camping Expo, the gun show, and Grand Rapids Hunting Time Expo. All members are welcome to volunteer some time working these booths.

<u>Vice President</u> – Gordon reported that the club carpet has been cleaned – see special note section.

<u>Secretary</u> – Terry provided an agenda for the Board meeting and also a preliminary agenda for the February regular meeting. The Board will provide additional suggestions for the agenda. Treasurer – Len – As of 1/21/2014 Total Income for January = \$6,122.80. Total Expenses =

\$3,790.96. The biggest expenses for January were the snow plow bill and the insurance for RSC Board of Directors. That was \$1,681.49. Detailed reports are available from the treasurer at every regular meeting if you wish to look over the books. The secretary also has a copy for the official records.

<u>Sgt. At Arms</u> – Dan Vincent reported that requests for range time by police agencies have been placed on the monthly calendar – see our website for that information.

Trustee Reports

<u>Dan Hankinson</u> – In addition to providing the good news about the increase availability (soon) of .22 ammo he indicated that the club investments will soon be looked into as our rate of return could possibly

<u>Dave DeVries</u> – no report.

<u>Steve Gardner</u> – Rifle target stand are in poor shape. When the weather breaks this will be attended to. **Steve requested March 25th and Sept. 3rd be approved for CMP make-up dates.** By motion Dave DeVries with support from Gordon – motion approved.

Steve also reported that the old Ruger Rimfire Shoot – Now the <u>National Shooting Sports Rim-</u> fire Challenge has been established to occur on May 10th. Lots more information to come.

The audio visual enhancement committee has been working on a final proposal to bring to the board and membership regarding the updating of our sound and visual system in the main building. This proposal will be ready for Board consideration in February.

Tim Hall requested that the club continue with a safety tip of the month. Discussion about our emergency first aid boxes – kept behind the door in the kitchen – each venue has a hook for these and they should be present when a shooting event is held. Safety meetings should be held before each shooting event – discussion about providing a list of safety rules to be given to late comers to such events as CMP. More discussion will follow. Every person is a safety officer at the club. If you see an unsafe action – SPEAK UP.

Bill Skallos – Next hunter's safety will be held in April. 2014 dates are on the calendar. Indoor archery started last week with 11 participants. All are welcomed to come. Bill is looking into a connection of websites between the new archery center and RSC. Inquires about shooting

events that come into the archery center would be directed to RSC and archery events that come to RSC would be directed to the archery center. This will be worked on by interested parties. Steven Mitchell – By general consensus Steve Mitchell will be the chairman for the By-laws revision committee and George will appoint the other committee members. Mike Roche/Dan Vincent made the motion to approve this – motion passed.

Steve made the motion to approve this and in addition authorize committee chairmen to be able to make changes to the website according to this code of conduct. Motion supported by Mike Roche - approved. 30 copies of the code of conduct will be available for interested members at the next regular meeting.


