## Civilian Marksmen Fun Shoot 2/28/2015







The Allegan State Game Area is the largest state game area in Michigan and one of Michigan's Wetland Wonders. Join us on Sunday, March 8 to improve wood duck habitat on it! Wood ducks need a cavity to nest in near wetlands abundant with vegetation and aquatic insects for ducklings to forage. This area of Allegan SGA contains one of Michigan's rare coastal marsh wetlands, similar to those on the East Coast, which are wood duck magnets. However, the surrounding forest is encroaching on the coastal marsh, so we're going to cut it back to preserve and expand this high-quality wood duck habitat. Join us March 8th, 2015 at 9am to cut trees and girdle others to prevent forest encroachment on the coastal marsh and to leave some standing deadwood in order to enhance habitat for wood ducks.

## 2015 Rockford Sportsman's Club CMP MILITARY RIFLE LEAGUE

All RSC CMP Military Rifle matches are open to the Public. RSC is a CMP-Affiliated Club, but these are not CMP/NRA "registered" shoots.

Entry Fees:	RSC Member	Non-Member	Junior(16 or under)
League Fees	\$25	\$30	\$15

League fees cover all five shoots for one class (Semi-Auto or Bolt).

The entry fee includes a CMP Membership Card and Qualification Letter, which entitles the holder to purchase firearms, parts, and ammo directly from CMP.

Standard "**As Issued**" military rifles with iron or peep sights (no optics) (e.g. M1-A1, M-1 Garands, M-1 Carbines, SKS, AK-47, AR-15, Springfields, Mausers, Enfields, Nagants, Kraggs, etc). Rifles may be available for use and ammo or chamber flags for purchase with advance notice.

Relays will be fired during each match based on both Course A (30 rds, 3-position @ 100 yds, SR-1 targets) and Course B (40 rds, 4-position @ 200 yds, SR targets). Each course will be preceded with (5) sighters.

Classes will include Semi-Auto and Bolt Action, Large and Small Bore. Other classes may be added as determined by the CMP committee. League shooters may fire both Semi-Auto and Bolt for the same League entry, but will compete in Semi-Auto class. One or more awards will be given for each class depending on the number of shooters.

Scores will be recorded, with the winners based on highest average score for the five (5) matches. Ties will be decided first by most "x"s, then by a ten (10) round Slow Fire, Standing shoot-off if needed, or other determinate as agreed by the parties. # Elk Poacher Caught After Receipt Found in Entrails

*Michigan United Conservation Clubs (MUCC) is considering a resolution to increase penalties for elk poaching at its Annual Convention in June. Increased penalties for trophy bucks were passed into state law last year after a similar MUCC resolution from 2011.*

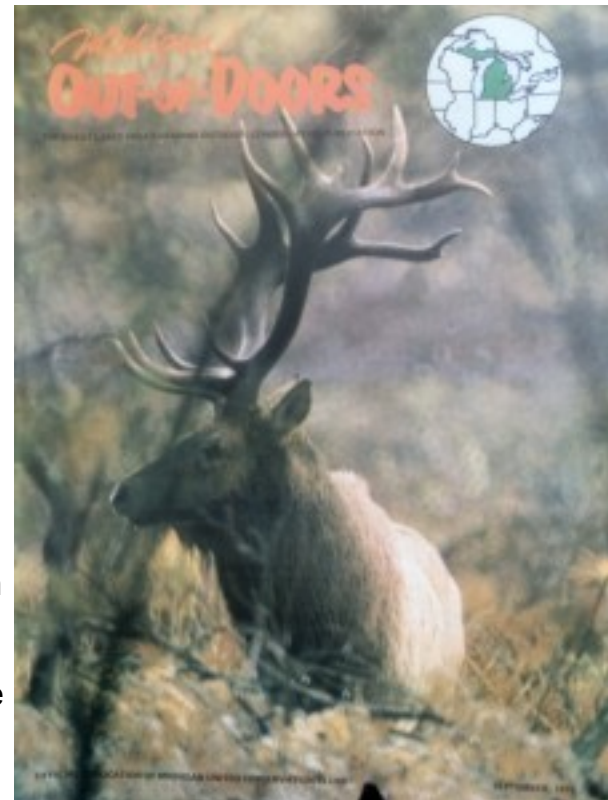
## DNR Press Release:

A Jackson County man has confessed to the illegal killing of a small bull elk during the firearm deer season in Otsego County, according to Michigan Department of Natural Resources conservation officers who investigated the incident.

A passerby discovered elk parts dumped along a rural road Nov. 29, 2014. A DNR conservation officer investigating the scene located a grocery store receipt among the entrails of an elk. A six-week investigation ensued, with a suspect being identified and interviewed. A confession was obtained, and charges are now being reviewed by the Otsego County prosecutor.

According to Lt. Jim Gorno, DNR law enforcement supervisor in Gaylord, conservation officers from the DNR's Gaylord Customer Service Center were assisted in the investigation by officers from southern Michigan, a diligent Report All Poaching (RAP) Hotline dispatcher, and a detective from the department's Special Investigations Unit.

"This case started with very limited clues and evidence, but through solid investigative follow-up, in conjunction with excellent teamwork being displayed by several of our officers around the state, it was brought to a successful conclusion," said Gorno. "It shows diligence and tenacity in investigating cases involving our high-value fish and game species."



Elk poaching carries fines of up to \$2,500, restitution to the state of up to \$1,500, loss of the firearm used in the incident and loss of hunting privileges for up to three years.

Conservation officers continue to investigate a number of poaching-related incidents involving elk in northern Michigan. Anyone with information regarding any incidents is asked to call the DNR Law Enforcement Division at the Gaylord Customer Service Center at 989-732-3541 or the 24-hour RAP Line at 800-292-7800.

Any fish, game or natural resources violation can be reported to the DNR's RAP Line or with the [online reporting form](#) available at the DNR website [www.michigan.gov/conservationofficers](http://www.michigan.gov/conservationofficers).

Information leading to an arrest and conviction is eligible for a cash reward funded by the Game and Fish Protection Fund. Information also may be left anonymously.

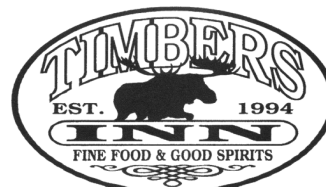
