Month in and month out there is a lot going on at Rockford Sportsman's Club. We all have our own uses and purposes for being members. To some it's a place to compete against others, a practice facility to hone in on skills, or just a place to relax and take the family plinking.

I've been told that the Rockford Sportsman's Club has changed over the years, that this club isn't what It used to be. I've run around this club for 25 years and think we forget where we come from and take for granted the great organization that we have.

Rockford Sportsman's Club was founded in 1945 by a group of World War II Veterans with the idea of creating a conservation based organization. Their purpose was simple, to promote the conservation of natural resources, fish and wildlife; to teach and promote conservation, hunter safety, sportsmanship, and to provide opportunities for fellowship of outdoor minded individuals through club activities and participation in the shooting sports. In 1945 we set out to be a nonprofit, non-stock, corporation organized on a membership basis. The Club is organized as a charitable and educational corporation

Our club makes serving and educating our community a priority year after year. Hunters' safety educates 200 students per year. Rockford Sportsman's club supplies Tracks Magazines to Rockford Public Schools. We fund a wildlife encounter program now being hosted by Krause Library. We work with Michigan Sportsmen Against Hunger to supply thousands of meals through deer donations and food collections. We work with Algoma Township and Vans Pines to hand out trees every spring. We open our doors to many different organizations with the goal of conservation and education in the outdoors.

Our club started nearly 75 years ago in the Corner Bar, Everything we have has been paid for and done by our members. All buildings and ranges have been built with the effort of active members giving their time, energy, and money to better the club. These same members have been the ones maintaining the club, building and grounds. We have grown from a small group in a local bar to a 325 family organization with 33 Acres, Clubhouse/Banquette facility, Shoot building, multiple ranges and much more.

This club is ours to maintain, improve, grow and hand off to the next generation at some point. Hopefully in better shape than it was when we joined. At the beginning of each meeting we raise our right hand and say 29 words, "I give my Pledge as an American to Save and Faithfully to Defend from Wasting the Natural Resources of My Country, Its soil, air, minerals, forest, waters and wildlife." Please take this to heart, pass on the ideas on which we were founded to others in our community and introduce them modern conservation and the shooting sports.

We are much more than just a Gun Club.

#### **Presidents Report – Ryan Cordes**

Summer clean up scheduled for June 8th. Probably burn some trash and will have lots of chores. Confronted by a few members after last meeting about the direction of the club. Please be reminded we are more than a gun club. We are a conservation club and it is about more than just shooting.

It was asked if there is any money in the budget for MUCC meetings. Tim is willing to go to the meeting but could use support with gas and other expenses. It was mentioned this was covered last year. There was a motion by Gordon to cover up to \$5,00 for expenses. Seconded by Ryan Cordes. Motion carried.

Shooting team has a raffle going for binoculars, range finder and knife. Tickets will be sold through August 6th and drawing will be held at the membership meeting. This money will be matched fifty cents on the dollar by the endowment.

Final meeting of the committee occurred, and it was very engaging. There was a finalized list of recommendations form the committee. One of the points was the club has limited visibility and no marketing strategy. Membership applications have dropped off.

Leverage successful events to promote other shoots.

Increase demographic collection on application.

The club shoots could be more interactive to increase fun. There was a strong desire to add steel targets to league shoots only.

To this end a set of rules was recommended for steel shooting which was drafted by the committee.

A suggestion was made to develop practice shoots to entice new shooters.

A motion was made to approve the steel target rules. Seconded by Dan Vincent. Motion carried.

These targets will be stored in a locked area and will only be used for sanctioned events/leagues.

Gordon made mention it might make sense to look at the rifle portion of SCTP and see if it might be adaptable to Neal's proposed new soot.

It was decided that there should be an open house on September 11th where the public can come try shooting activities.

An idea was fielded to offer free vouchers for shooting activities.

A motion was made to approve the suggestions and seek a volunteer to facilitate each action point. Seconded by Jim Hughes. Motion carried.

## **Instant Pot Venison Stew**

#### Serves 6

## **Ingredients**

#### Meat

1 lb Venison

#### Produce

- 2 cups Carrots
- 1 cup Celery
- 2 Garlic cloves
- 2 tsp Herbs de provence
- 1 Onion
- 4 cups Potatoes

#### **Canned Goods**

4 cups Beef Broth, unsalted

#### **Condiments**

3 dashes Worcestershire sauce

### **Baking & Spices**

3/4 tsp Black pepper

1 tsp Salt

#### **Oils & Vinegars**

1 tbsp Olive Oil

#### Other

1 15 oz. can diced tomatoes



#### **Directions**

- Dice the potatoes, carrots, celery and onion. Mince the garlic. Set aside in a bowl.
- Dice the venison into bite-sized chunks, being sure to remove any of the silvery sinew tissue. Leaving this on makes the meat tough.
- Add the olive oil to the base of the Instant Pot and add the cubed venison.Add the spices and seasoning.
- 4. Turn the Instant Pot to "Sauté" for 10 minutes.
- 5. Allow the venison to sauté for 5 minutes and add the bowl of vegetables. Sauté until the cycle ends with the lid off.
- 6. Add the tomatoes, broth and Worcestershire sauce. Stir well and secure the lid.
- 7. Select "Manual" or "Pressure Cook" on high pressure and adjust the time to 30 minutes. Allow the Instant Pot to do its thang. Go pour some wine, do your nails, whatever.
- 8. When the cycle finishes, allow it to naturally release for 10 minutes before turning the knob to venting according to manufacturer's instructions.

Allow the Instant Pot to vent fully, remove the lid and serve!
