Treasurer's Report: Jim Hughes

- End of 2019 report and the books are close to where they should be.
- Wanted it to be known that the 50/50 raffle is divided between the winner and the club utilization.
- Hunter safety profited \$1,200
- Firearm fundraising netted approximately \$30,900
- Fundraising raised \$26,000 with a net profit of \$1,600 including rentals.
- Membership is down a few thousand dollars.
- \$19,000 was spent this year on capital improvements.
- SCTP expenses exceeded revenues by approximately \$500. There is an endowment associated with SCTP and Gordon and Jim H will meet about if this can be utilized. Gordon clarified that this money is matched and has a return of roughly 5% a year. The endowment has grown by approximately \$23,000 this year. Dan V clarified that if you no longer run a team you no longer have access to the funds and would not be able to draw off the endowment. Going forward Jim indicated he will separate the endowment.

Sergeant of Arms Report: Dan Vincent

• Thanks to everyone that has been trying to keep the area clean of snow. Please shovel the whole area if you are using it.

Committee Reports

Skeet and trap - Winter league just started will continue for 10-12 weeks. NSSA will shoot 1/8 at 4pm. Targets are coming tomorrow, and assistance would be appreciated storing them. This would be between 3pm and 4pm on 1/9. **SCTP** – No additional report.

CMP – Completed fall winter 2019 CMP match in September. Won't start up again until March but there will be a few fun shoots with the next being on 1/25. This will be a handgun, shot gun and rifle shoot. Most any handgun issued to anyone ever in the service qualifies. 25 rounds at 25 yards with handgun. 25 birds on the skeet field. 25 rounds on the 100-yard line at standard CMP line. Invocation was given by Tim Hall.

Kim Neveau from Rockford Chamber of Commerce was present to talk about membership. She indicated there are partners from Sparta, Rockford and Cedar Springs. She reported there is always great networking through the Chamber of Commerce. Networking activities include biweekly lunches, thirsty Thursdays, March Rockford Expo which usually has 10,000 attendees. The booth is \$150. There are also breakfasts and a golf outing. There is also a free publication that can be utilized to highlight Chamber of Commerce Members.

Curt Becker updated about the Glock challenge including the fact that Glock donates certificates to the event. - It was agreed the club might need a new extension ladder. A motion was made by Gordon to get 2 step ladders and 2 extension ladders. Dan will get a price.

- A letter was received indicating RSC needs an electric permit for the new sign. Gordon will address this with the township.
