Board Meeting Minutes July 21, 2020 Call to order at 7:00 PM

President's Report: Ryan Cordes

- A member was recently observed covering up the cameras and was asked not to do so again. Please
 address this at any time you see someone tampering with the cameras. They exist for the protection of the
 club and should be treated with respect.
- A discussion occurred who will run defensive pistol next year as this is Glenn Vanorman's last year. A replacement is being sought but no individual is identified yet. It was mentioned that this year Glen is collecting money only and he might be asked to do this again next year.
- The Rimfire challenge needs a new chairperson next year as well. It is not known if a replacement has been identified.
- Ian Fitzgerald was in communication with Ryan about the final RSC delegates for MUCC. Ryan Cordes & Gordon Pickerd will fulfill the obligation for this year.
- The August membership meeting will likely be held outdoors.

Vice President's Report: Gordon Pickerd

- The Rockford team performed well at Nationals. There were some college coaches recruiting at the event. Chris medaled in international skeet. Riley and Blake performed well also.
- Natasha Smith wanted to get some range time in and Gordon will host this.

Secretary's Report: Scott Stanley

• 22Ir Reactive Target shooters did not have a scheduled shoot on 7/14 but a few members ran some informal stages. This was a free practice shoot run by Steve Lamonoco and no fees were collected.

Membership Secretary's Report: Kevin Kubiszewski

- Five new membership applications were presented: Jeffrey Schwander, Crystal Newman and Frank Sebastian, Rob Wollnery, Jeremy Verwys, Mike Long Jr. There was a motion to approve these individuals for associate membership by Kevin Kubiszewski whish was seconded by Steve Mitchell. Motion carried.
- Two members are seeking retired status. There was a discussion about the length of membership required to seek retired status. This will be researched by Kevin and he will re-introduce the request if appropriate.

Treasurer's Report: Jim Hughes

- Checking is at \$45,000.
- Income of \$56,600 for first six months of 2020. Expenses were \$31,000.
- SCTP is reconciled through June. As of June 30th, the SCTP bank account was at \$13,600. The program took in over \$25,000. SCTP has revenue in excess of expenses by \$10,500.
- The SCTP will put a committee in charge of reviewing the check book as a second check.

Sergeant of Arms Report: Dan Vincent

- There is a concern regarding the membership status of John Olinger. Steve Mitchell will research if there is a discrepancy in his invoice.
- A member asked for permission to put in a fire pit on the trap and skeet field at his own expense. Gordon suggested this might be best by the flagpole so it could be used by those shooting at the 100 yard line. It was mentioned that this might be nice during sight in days. Ryan mentioned we should be vigilant about ensuring this does not become a dumping ground. John Cordes suggested it might be beneficial to have a cover for the fire.
- NSAA is schedule August 8th and 9th .
- Please talk to anyone who is witnessed shooting before official hours. RSC wants to be a good neighbor and avoid complaints.
- Dan inquired if RSC should consider putting a cap on new memberships.

Sergeant of Arms Report Cont.

- Dan requested his name be taken off the list of people who can provide tours. He indicated most of the
 requests leave their number too quickly to be discernible. Ron D mentioned it might be desirable to have
 some form of screening for membership as it has been observed some members might not have vast
 knowledge of shooting safety.
- The new machines for SCTP arrived.

Tim Hall

• Tim spoke with Ian Fitzgerald and RSC is registered to vote for MUCC. RSC votes will be counted and there is no issue regarding when the MUCC dues are paid in the calendar year.

Steve Mitchell

- Steve re-drafted the range rental agreement amending condition C placing the responsibility for finding a range officer on to the rental party. It also indicates that there must be one RO per five shooters. Steve made a motion to accept the rules as amended. Seconded by Ryan Cordes. Motion carried.
- Steve indicated it might be advisable to update the club archery rules as there is no longer active archery at RSC. Kevin and Ryan mentioned they have observed archery at the 25/50-yard line and desired that to be allowed to continue. Steve suggested we amend the rules to indicate members can use the 25/50 range and you must bring your own target.
- Steve mentioned he will utilize the newsletter to notify of by-law changes.
- The air conditioning group met recently and discussed the modification of the clubhouse. The main elements of discussion are energy efficiency, air quality, and maintainability. The goal for 2020 is to have a design in place for the upgrade. George suggested this project occur as soon as possible and suggested the target be spring.
- Provided the report for RSC investment portfolio. The first quarter the investments lost %20 but gained back %18 in the second.
- The rule binders will be ready for the next month.
- Steve had to replace the camera and switch board on the action range. Steve indicated it might be desirable to replace this with a stationary camera. This was agreed to by the board.
- A project leader was identified for the pavilion re-roofing job. Don Groters believes he can do this for \$1,500 as opposed to the \$4,600 budgeted. Steve indicated this project would be completed with matching shingles. A motion to move forwarded by Gordon, seconded by Dan Hankinson. Motion carried.

- Thanks to all that showed up the first week in June for cleanup. Will try for a date in August if it is not too hot.

- SCTP one shooter is leaving for Ohio tomorrow morning to compete. There will be nine shooters going to nationals this year which is the most Rockford has ever sent. Shooting starts Wednesday at 8am and will go through Friday. 3,000 shooters expected at the competition. The facility is 1000 acres so there will be plenty of room for social distancing.
- The parents of Rockford shooters donated the money to add two more machines to the skeet field which can throw international clay pigeons. These machines throw the birds approximately 20mph faster than a standard machine which gives our student shooters a leg up in training.

RSC BYLAW AMENDMENT (Highlighted in BLUE)

In order for the Club to take advantage of the internet the state of Michigan requires that our Bylaw's be amended. For RSC this requires only and addition and results in no other changes.

Section 7.3 Board of Directors Meetings

- 1. A Regular Board of Directors Meeting shall be held on the third Tuesday of each month. Any exceptions shall be announced at the prior Regular Meeting.
- 2. Meetings shall be open to all Members in good standing but only Board Members may vote in matters coming before the Board of Directors.
- 3. The Chairman of the Board may limit debate from non-Board Members in matters before the Board.
- 4. The December Board meeting shall be attended by both incoming and outgoing members.
- 5. Special Board of Directors meetings may be called by the President. The President must call a Special Meeting of the Board if requested in writing by any two (2) Board Members. The written request must state the purpose of the Special Board of Directors Meeting.
- 6. Electronic board meetings and voting may be allowed on time sensitive or emergency matters when necessary.

 The electronic voting (E-Mail) process must follow the club 'Ballot Voting Procedure' in compliance with the Club Policies and Regulations documents.




