January 18, 2022 RSC Board Meeting

Call to Order- 7:00

Invocation Lead by Tim Hall

Scott Vanderplow visiting for SCTP:

- Asked if we would be willing to offer up any more of a sponsorship for the team. Said that other clubs are offering monetary donations in the form of free lines to a certain dollar amount.
- Dan Vincent has suggested that the price we are offering the kids is already discounted given the cost of birds has risen by 20-30%.
- Discussion about why we were sponsoring the team, and what the return was for us as a club. Potential of new shooters staying with the club is very inviting. Helping kids & our community as well.
- Ryan Cordes stated that there is a lot of potential with the team, and made a motion that we donate \$500 worth of line fees. Karen Kronberg seconded the motion. Motion carried.

Gordon Pickard visiting for SCTP:

- Gordon is asking if we can get the lighting updated on the international skeet field.
- Gordon says Midway USA is offering grants to help offset the money if we want to apply for the money. Says the lighting improvements would improve both the international & regular skeet.
- Ryan Cordes & Dan say that the LED lighting is already in the works. Said that we are getting a quote to replace
 all lighting on all of the fields so the timing is right for the grant.
- Also said that we went for a grant last year, but were turned down. Would be interested in applying again this year
 if we stood a chance to get some money. Looking for someone with past grant writing experience to help out with
 writing the application as we would stand a better chance of getting approved if it is done the proper way.
- Suggested that we put the cost of poles & all electrical work into the grant application.
- Dan Hankinson asked for the Grant Application so we can get it filled out & turned in.
- Gordon also suggested that he has done an investigation into the endowment to see what our return looks like.
 Says that from our original investment of \$2500 we have received over \$16,000 in returns.
- Said Pheasants Forever is sending a firearm for SCTP.
